# Privacy Policy



Decent, Inc. ("us", "we", or "our") operates the website at https://www.decent.com.

Services and products provided or offered by us via this website, and any related services and products provided or offered by our partners are collectively referred to herein as our "Service."

This page informs you of our policies regarding the collection, use and disclosure of personal data when you use our Service and the choices you have associated with that data.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. #### **Definitions**

#### Service

"Service" means any services and products provided or offered by us via this website, and any related services and products provided or offered by our partners.

#### Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

#### **Usage Data**

Usage Data is data collected automatically either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

#### Cookies

Cookies are small files stored on your device (computer or mobile device).



# **Information Collection and Use**

We collect several different types of information for various purposes to provide and improve our Service to you.

# **Types of Data Collected**

### **Personal Data**

# **Tracking Cookies Data**

We use cookies and similar tracking technologies to track the activity on our Service and we hold certain information.
